Rules, Regulations & Pickleball Etiquette

Mount Carmel Pickleball Club, Inc.

The purpose of these rules and regulations is to establish procedures and controls for the safe, fair, efficient and practical use of our pickleball courts and equipment, for the optimum benefit of MCPC members and the public; and to protect the courts and surrounding facilities from damage.

Basic Pickleball Etiquette:

- 1. Good sportsmanship is the rule. We love the game, but it is only a game. Respect all players.
- 2. Remember, during open play sessions we are trying to get members to mix it up so the various level players can mix in and hopefully improve their play, and to get a better understanding of what it takes to move up in skill level. All players like to improve. It bears repeating-the better, more experienced player should occasionally make themselves available to play with or against the less experienced players. Remember, we are all in the same club.
- 3. Begin each game with a greeting by acknowledging the other players and introducing yourself if you don't know them. During regular play, players play with all skill levels. No complaints. Good sportsmanship is the rule.
- 4. Follow and respect USAPA rules and regulations.
- 5. Never yell at, swear at, or say hostile or sarcastic words to any player in anger. Abusive language will not be tolerated on or around the courts.

Rules and Regulations:

- 1. Membership shall be available to all persons 15 years of age or older. Memberships in the MCPC are individual, non-transferable, and are valid for one calendar year. The Fiscal year for the club is January 1st through December 31st.
- 2. Non-Members and players under 15 years of age are prohibited from using the courts during MCPC established and scheduled play times, and during MCPC special events.
- 3. Guest policy: Members are encouraged to promote the development and growth of the MCPC. Members may sponsor one guest on a one-time basis to attend and play during scheduled Club play times. The sponsoring member and guest will

be required to sign in at the court. The member will be responsible for informing their guest of our Rules, Regulations, and Etiquette. The sponsoring member should encourage their guest to become a Club member in order to continue to play and participate in Club activities on a regular basis.

- 4. Dress Code: casual, comfortable clothing is acceptable. Shirts and proper court shoes are mandatory and must be worn at all times. Acceptable court shoes are soft-soled tennis type shoes that will not harm the surface of the courts that are part of the MCPC facility.
- 5. Court lights will be available for night play and will automatically shut off at 10:00 P.M.
- 6. MCPC will provide paddles, balls and other necessary equipment to members during scheduled play time and for special events. (Members are encouraged to obtain their own paddle for court play). MCPC is not required and does not provide paddles or other club equipment to non-members or to the public.
- 7. Rotational Play System: This system utilizes a rotational play system during scheduled play hours. If your group has finished a game and others are waiting, your group must relinquish the court to allow other players the opportunity to play.
- 8. All members shall read and comply with all posted Court Rules.

These Rules have been reviewed and approved by the MCPC Board of Directors and became effective July 23, 2020. These "Rules" may be updated at periodic board meetings based upon changing needs and input from members. It is the responsibility of all members to read all notices posted at the pickleball courts.
